How the process works

- Interested countries will send their application and their Master Chef Curriculum to the WACS Master Chef Committee.
- Documentation will be evaluated against the established criteria.
- The interested country allows a WACS appointed commissioner to observe the final Master Chef examinations.

The WACS Board has sanctioned this idea and the program for the WACS International Certified Master Chef at their meeting in San Antonio and Paris and will give its full support.
